

# Drive Smart – Stay Safe 2010 Pick Up Truck Sweepstakes

## Introduction & Eligibility

Sweepstakes is open to anyone whom is an active and qualified driver for RWI Transportation LLC or R&O Transportation LLC as of 12/31/2010. Not reporting a collision, roadside inspection or citation within company policy or governmental regulations, or submitting a falsified log sheet (duty status sheet) will result in disqualification.

## Drawing

The winner selected will be contacted by telephone or mail after the drawing. The return of any Prize notification as undeliverable, or the inability to otherwise contact the winner, may result in disqualification and the selection of an alternate winner. If you win, your acceptance of the Prize constitutes your permission to use your name and likeness for promotional purposes without further compensation, except where prohibited by law.

## Entry Period

## Entering the Sweepstakes

There are three (3) ways in which you may enter the Sweepstakes. Your entry(ies) must be considered to be an "Eligible Entry(ies)" for it to be included in the Sweepstakes and for it to have a chance of being selected as the winning entry. The three (3) ways in which you may enter the Sweepstakes are given below:

*No Violation Roadside Inspections:* If no violations were noted on the roadside inspection and the roadside inspection was reported to management within the next 24 hours, via scanning, fax or hand delivery. Each No Violation Roadside Inspection received during the Entry Period will be an Eligible Entry to the Sweepstakes.

*Attendance in Drive Smart – Stay Safe Training:* These training programs will be made available to sharpen your skills as a professional driver. Each successful completion of a training segment during the Entry Period will be **FIVE** Eligible Entries to the Sweepstakes.

*Violation and Collision Free Driving:* Accumulating over 180 hours of on-duty or driving time under Company dispatch in a calendar month during the entry period **without** one of the following listed below will be an Eligible Entry to the Sweepstakes:

- A preventable collision as determined by the Safety Committee
- A conviction of a traffic violation
- An inspection resulting in a documented:
  - Hours of Service Violation;
  - Out-Of-Service Violation; or
  - Citation or Warning of a traffic violation.

## Limits on Entry

There is no limit on the number of times that you may enter the Sweepstakes, regardless of the method of entry. RWI Transportation, LLC or R&O Transportation, LLC is not responsible for lost, misdirected, incomplete, illegible, or late entries, none of which are considered Eligible Entries.

## Odds of Winning

Odds of winning are dependent on number of Eligible Entries received.

Winner is responsible for vehicle registration, license, title and insurance fees and for all costs associated with any available upgrade/option packages and any other expenses related to the acceptance and use of the prize not specified herein. Winner must take delivery of vehicle within 30 days of notice of availability. Winner must have valid U.S. driver's license and proof of insurance to take delivery. Vehicle awarded may differ from any vehicle shown in promotional materials. Vehicle color, options and equipment will be determined at our sole discretion.
